About the Barnaby Webber Foundation

Barnaby was killed in a senseless, horrific attack in Nottingham on the 13th of June 2023. He leaves behind a family broken by grief and loss but determined NOT to let him be taken in vain.

He lived his life with a simple 'if he liked you, he liked you' mantra. With no time or judgement for creed, colour, sexuality, religion or background. His inclusivity, quiet patience with others, and sheer generosity of his time, prove what an extraordinary 'ordinary' person he was.

Our Foundation has been created to remember and celebrate Barney.

We support young people who are facing life challenges and provide grassroots cricket clubs with essential equipment.

Our two priorities for funding:

1. To provide support and inclusion for young people aged 18 and under who are facing life challenges (be it physical, mental, emotional or social). This may be through other charities, schools or organisations but can also be directly to an individual or family.

2. To support grassroots cricket clubs through the provision of essential equipment and items needed to encourage young boys and girls (aged 18 and under) to get involved in playing cricket.

Whilst the Foundation would like to fund all the applications we receive, this is not possible. We will evaluate all applications fairly and without any bias. If you are successful, we will expect an interim and final report on how the support from the Foundation has helped you as a condition of our funding. We will not publish this information without your permission. The trustees of the Barnaby Webber Foundation will always consider what they feel Barnaby would have wanted to fund.

Guidelines:

- When writing your application always keep the requirement and/or project in mind.
- Write in plain English. Use short sentences and avoid acronyms and jargon.
- Be specific about what you plan to do.
- Focus your application on our priorities.
- Provide evidence that your work is needed.
- Include all the information asked for and any additional information or documents you may have.
- Take care to meet the deadlines.
- Make your budget as specific as possible.
- Do not include any non-specific items in your budget.
- Do not apply to more than one funder for the same costs at the same time.
